On 7 February 2018, Council sent out 1700 notification letters regarding the exhibition of the Gladesville Planning Proposal which relates to the land shown overleaf. The Planning Proposal was exhibited from 21 February to 20 March 2018 and a total of 130 submissions were received. These submissions have been reviewed by Council staff and a report prepared regarding the merits of the proposal.


